

FORT NEW SALEM AWARDED FEDERAL GRANT

USDA Rural Development has granted the Fort New Salem Foundation, Inc. \$56,650 to install a drainage system at Fort New

The drainage system will consist of French drains around each of the buildings that will be tied into a central line to funnel the water off-site. Drains will also be installed around the perimeter of the parking lot to prevent water that comes off the surrounding hills from flowing across the lot, through the grounds and under the buildings. This drainage system will help to insure the preservation of one of the Fort's primary assets, its historic log structures

The grant funds became available nationwide to counties that had been declared national disaster areas due to the recent flooding. The funds are to be used to encourage business development in these areas. The Fort became aware of the availability of the funds due to a call that

came to Terry Schulte at the Harrison County Planning / Landmark Commission Several projects at the Fort were considered. Cheryl Wolfe, Program Director -Rural Business and Cooperative Programs of the West Virginia office of the USDA, visited the Fort and suggested that the drainage plan stood the best chance of being funded. The grant application was then completed and submitted through the guidance of board member Becky Nesbitt Thanks to former director Tim Brady and board members Mark Kiger and Stephen Kelly for their great assistance in getting the right information to Becky for the grant application.

The Contractor Bids were recently finalized and the work will be conducted this spring as weather permits

FORT NEW SALEM RECEIVES STATE GRANT

The Fort New Salem Foundation was recently notified by the Community Development Division of the West Virginia Development Office that we have been awarded \$20,000 in development grants through the Community Participation Program.

Since taking ownership of the facility, our foundation has worked on various cabin restorations. This grant is earmarked for the rehabilitation of the Blacksmith Shop. Cur-

rently, volunteers (Brian Moore and Ronnie Davisson) have cleaned out the cabin, worked on the forge and repaired the bellows. This phase of the project will involve the removal and reconstruction of the roof, walls and doors as well as an expansion of the current size and addition of a shed on the back of the cabin.

The foundation extends its thanks to the West Virginia Legislature for their continued support of the rebirth of

Fort New Salem and the Harrison County Commission for their assistance in the efficient administration of this grant.

We are finalizing the design and bid specifications and hope to have this project completed by the end of this summer!
